- DCC response ref flooding from the sewer on Luke Lane. Further to your enquiries with the Local Planning Authority regarding flooding and development on Luke Lane, Brailsford, I have been in touch with Severn Trent Water (STW) regarding the flooding sewer as this is part of their infrastructure. According to the submitted documents to discharge the relevant planning condition, the surface water discharge off the miller Homes site to the West of Luke Lane was to be limited to 5 l/s as agreed with STW, they will check that it is being limited as agreed and let me know the outcome. In relation to other proposed development in Brailsford our team are a statutory consultee for major development with surface water implications therefore the Local Planning Authority seek our comments accordingly to ensure that an applicant's surface water proposals have been scrutinised. I will be in touch as soon as I have further information from STW in relation to the surface water discharge into the sewer on Luke Lane.

- DCC response ref Ednaston Speed Survey. To provide you with a bit of background information on this issue, I was originally asked by the Police to help interpret how the speed surveys from 2010 and 2018 for Ednaston compared. The summary sheet that I created was not intended to be used in a presentation, it was just to enable the Police to understand how we interpret the results. I have included attachments of the speed survey data from both 2010 and 2018 for your information. The Parish Council is free to present this data however they see fit and do not have to use the summary note that I had sent to the Police.
- Unfortunately neither of the speed surveys carried out included separate readings for HGV's. The Police requested the most recent survey in 2018 and I can only assume that they did not request separate reading for HGV's.
